Location of the event is the Brevard Community College Campus in Cocoa (Same as last year). To get to the campus take the Beachline (SR 528) to the Clearlake Road exit in Cocoa. At the bottom of the exit, bear right. At the stop light, turn left onto 524. Road curves right and becomes Clearlake. Stay on Clearlake Rd. heading south until you get to the campus (about a mile or 2). Turn right at the 7-11 on the south edge of the campus and follow the signs.

From I-95 take the Beachline (528) exit and head east until you get to the Clearlake Rd. exit, then follow the same directions.

*"For any USFA competition that is not specific to an age group, the fencer must be at least 13 years old as of January 1 of the current fencing season. The fencing season is the same as the membership year, August 1 through the following July 31. The exemption to this rule is that a fencer who is on the Junior national point standings (NRPS) at the entry deadline for the competition and is younger than 13 as of January 1 of the current fencing season will be allowed to compete in the USFA competitions not specific to an age group.

Examples of such competitions are: "Open", "Unclassified", "A" competitions, "D" or under competitions, Team competitions of any category unless specified for juniors or similar age restricted category."
